The members discussed about the different faculties and the departments therein to be established in Sri Sri Aniruddhadeva Sports University for running its various activities in compliance with the decision against Agenda No.-1 in the first Adhoc Executive Council Meeting of Sri Sri Aniruddhadeva Sports University held on 22nd July, 2020. Prof. L. N. Sarkar suggested that one more department of Sports Management may be included in the school of Interdisciplinary Studies which was accepted by the members. Thus, all the members unanimously approved the following three schools with different departments to be established in the university:

- A. School of Human Kinetics and Health
 - a. Department of Undergraduate Studies
 - b. Department of Physical Education
- B. School of Sports Studies and Coaching
 - a. Department of Sports Sciences
 - b. Department of Sports Coaching
 - c. Centre for Adventure Sports
- C. School of Interdisciplinary Studies
 - a. Department of Yoga & Naturopathy
 - b. Department of Sport Management
 - c. Department of Sports Journalism

Agenda Item 4

TO DELIBERATE AND APPROVE THE BPED (HONS.) 4-YEAR UNDERGRADUATE PROGRAMME IN PHYSICAL EDUCATION WITH MULTIPLE EXIT OPTIONS AS PER THE NEW EDUCATION POLICY-2020, AS APPROVED BY THE FIRST ACADEMIC COUNCIL MEETING CALLED FOR DISCUSSING THE ISSUE ON 15TH SEPTEMBER, 2020.

After detailed deliberations, the members resolved and approved the BPEd (Hons.) 4-year undergraduate Professional Degree Programme in Physical Education with multiple exit options as per the New Education Policy-2020, as proposed by the first Academic Meeting called for discussing the issue on 15th September, 2020 by inviting some of the experts of physical education and sports. Shri V. S. Chauhan (Arjun Awardee) suggested that 25% seats in the program should be reserved for the students of Assam and 25% seats should be reserved for the other 6 north east states. However, the Vice Chancellor suggested that the matter be taken up with the Government of Assam in this regard.

Agenda Item 5

TO DISCUSS AND APPROVE THE POST GRADUATE DIPLOMA IN SPORTS COACHING (TWO-SEMESTER PROGRAMME) AS PER THE NEW EDUCATION POLICY-2020.

Extensive discussion took place among the members on the draft proposal for starting Post Graduate Diploma in Sports Coaching (Two-semester programme) as per the New Education Policy-2020. The committee suggested that instead of one paper of Theory of Sports there should be two papers on the subject in each semester and the papers of sports sciences may be combined which was accepted by all the members. Accordingly, the proposal for Post Graduate Diploma in Sports Coaching was approved unanimously with some modifications.

Agenda Item 6

TO DISCUSS AND APPROVE THE GUIDELINES FOR APPOINTING ADJUNCT FACULTY, GUEST FACULTY AND VISITING FACULTY IN SRI SRI ANIRUDDHADEVA SPORTS UNIVERSITY.

The members placed their views on the guidelines for appointing Adjunct faculty, Guest faculty and Visiting faculty in Sri Sri Aniruddhadeva Sports University and agreed with the guidelines for these positions. Thus, the proposal to appoint Adjunct faculty, Guest faculty and Visiting faculty was unanimously approved.

All the members were happy to see this new proposed undergraduate programme in physical education with title "BPEd(Hons.)" – A 4-years professional course with the multiple exit options under NEP 2020. They congratulated the University for taking a lead in this direction.

The meeting ended with the vote of thanks to the chair.
