Decisions in the Meeting

The 1st meeting of the Executive Council of Sri Sri Aniruddhadeva Sports University was held on 5th October, 2020 at 3.30 PM in online mode. The meeting was chaired by Prof. J.P. Verma, the Hon'ble Vice-Chancellor of Sri Sri Aniruddhadeva Sports University (SASU), Chabua, Dibrugarh. He welcomed each member and got them introduced with other members. At the outset he briefed about the journey of this newly established University by the Government of Assam and explained the kind of infrastructure and other resources available at the disposal of the University. He explained that the Dibrugarh University has agreed in principle to give space for the conduct of its academic programme and the sports fields that are available for its sporting activity. Looking to the facilities available the academic council has deliberated extensively and proposed some of the academic programmes with detailed guidelines looking to the Covid-19 pandemic to be considered for starting form session 2020-21 as per the administrative feasibility.

He briefed the members that after his meeting with the Hon'ble Chancellor of the University on 11th September in the Raj Bhavan, Guwahati, the Hon'ble Chancellor has suggested that the university should prepare all its academic programmes as per the New Education Policy 2020 of the Govt. of India. Accordingly, the university has developed BPEd (Hons.) 4-year degree course along with Academic regulations which was deliberated extensively in the academic meeting on 15th September 2020 and then in the Academic Council meeting on 30th September and got it approved.

The Vice Chancellor explained that this meeting of the Executive Council has been called specifically to get the approval of the BPED(Hons.)- 4 years professional degree programmeas approved by the Academic council meeting. The second meeting for discussing other agenda items shall be organized shortly as per the convenience of the members. The Vice Chancellor requested the Registrar of the university to present the agenda items.

Agenda Item 1

INTRODUCING MEMBERS OF THE FIRST EXECUTIVE COUNCIL AND APPROVING STARTING OF AN UNDERGRADUATE PROFESSIONAL DEGREE COURSE IN PHYSICAL EDUCATION WITH TITLE "BPED (HONS.)- 4 YEARS PROGRAMME" WITH MULTIPLE EXIT OPTIONS UNDER NEW EDUCATION POLICY OF GOI 2020 AS SUGGESTED BY OUR HON'BLE CHANCELLOR. THIS COURSE ALONG WITH ACADEMIC REGULATIONS HAS BEEN APPROVED BY THE FIRST ADHOC ACADEMIC COUNCIL IN ITS MEETING ON 30.09.2020 WITH AGENDA ITEMS NO. 2 & 4 HELD IN ONLINE MODE. (ENCLOSURE 1 & 2)

After detailed deliberations the Executive council considered and approved the recommendation of the Academic Council meeting held on 30th Sept and gave approval to start BPED (Hons.)- 4 years professional degree programme with multiple exit options as per the NEP-2020; and, academic regulations of the University, to run this programme from the session 2020-21.

However, Shri. Onkarmal Kedia, and Dr.Subhash Basumatary have suggested that the Boxing and Archery respectively should also be included in the curriculum as they are priority sports in Assam. The Vice Chancellor assured that these suggestions shall be passed on to the Academic council for consideration during second revision of the programme as and when it is done. However, he assured that as soon as facilities for these sports are available it may be offered to the students.

Agenda Item 2
