



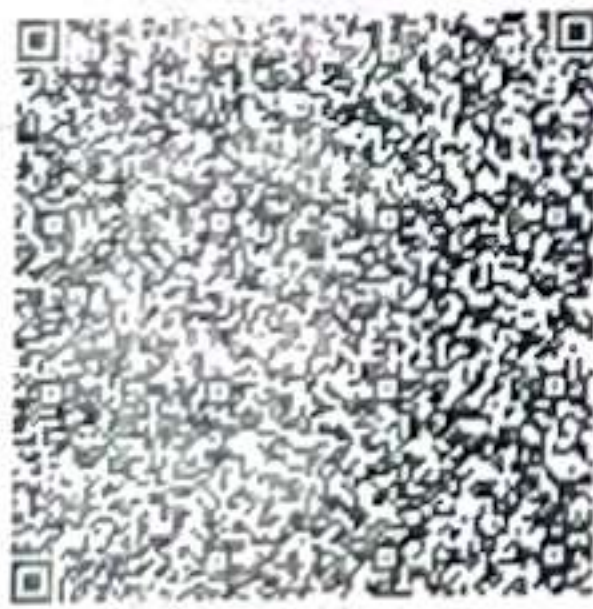

MEMORANDUM OF UNDERSTANDING

BETWEEN

SRI SRI ANIRUDDHADEVA SPORTS UNIVERSITY

AND

THE DIRECTORATE OF HISTORICAL AND ANTIQUARIAN STUDIES, ASSAM

This Memorandum of Understanding (MoU) is executed on this the 21st day of May 2025

-BETWEEN-

SRI SRI ANIRUDDHADEVA SPORTS UNIVERSITY, established by the Government of Assam through an act of the Assam Legislative Assembly (No. LGL. 164/2018/7) in the city of Chabua, Dibrugarh, presently operating from its temporary office on the 2nd floor of DICC Building, Milan Nagar, Dibrugarh, Assam, India hereinafter called and referred to as 'The University', the First Party of the First Part, being represented herein by its Registrar, Shri Pankaj Borthakur, aged about 45 years, son of Late Sarat Borthakur.

-AND-

THE DIRECTORATE OF HISTORICAL AND ANTIQUARIAN STUDIES, ASSAM functioning under the Department of Indigenous and Tribal Faith and Culture, Government of Assam, having its office at Panbazar, Guwahati, Kamrup (Metropolitan), Assam, PIN - 781001, hereinafter referred to as 'The Directorate' or 'Second Party', represented by its Director, Dr. Sangeeta Gogoi, aged about 56 years, daughter of Late Trailukya Nath Gogoi.

WHEREAS THE Sri Sri Aniruddhadeva Sports University is a premier university of the State of Assam offering a range of academic programmes and conferring degrees across various disciplines;

AND WHEREAS the Directorate of Historical and Antiquarian Studies, Assam, is a premier institute of the state functioning under the Department of Indigenous and Tribal Faith and Culture, Government of Assam, with the main objective of collection and preservation of old manuscripts and other antique materials related to the history of Assam and promoting researches on the culture and heritage of the state.

AND WHEREAS, both parties desire to promote and develop mutually beneficial academic, research, cultural and archival collaborations.

NOW THEREFORE, THIS MEMORANDUM OF UNDERSTANDING WITNESSETH AS FOLLOWS:

1. **SCOPE OF COLLABORATION** The University and the Directorate agree to collaborate on:
 - a. Joint research in history, archaeology, antiquarian studies, ethnography, translation, digitization, preservation, and conservation.
 - b. Organization of joint workshops, seminars, and conferences for students, scholars, and staff.
 - c. Exploration of the socio-cultural significance of sports throughout history.
 - d. Study and analysis of historical sports artifacts, documents, and materials.
 - e. Research on the origins and development of traditional sports, rules, and methods.
 - f. Conduct of workshops on ancient Assamese scripts and inscriptions spanning the 4th to 19th century AD.
 - g. Exchange of research information and materials of mutual interest.
 - h. Promotion of studies on indigenous and tribal faith and culture.
 - i. Mutual access to library and archival resources.
2. **RESPONSIBILITIES OF THE DIRECTORATE** a) Facilitate the collection and archiving of unpublished research from the University's community. b) Support publication of academic work from the University. c) Provide internship opportunities to University students, based on infrastructural availability and request.
3. **GOVERNING PRINCIPLES** All collaborative activities shall comply with the respective rules and regulations of the University and the Directorate.
4. **VALIDITY** This MoU shall remain in force for a period of three (3) years from the date of signing and may be extended by mutual written agreement.
5. **TERMINATION** This MoU may be terminated by either party with ninety (90) days' written notice. Ongoing activities shall be completed to the extent practicable.
6. **DISPUTE RESOLUTION** Any disputes arising shall be resolved amicably through mutual consultation between the University and the Directorate.

7. JURISDICTION Jurisdiction for legal matters pertaining to this MoU shall lie exclusively with the competent courts at Dibrugarh and Guwahati, Assam.
8. NON-EXCLUSIVITY This MoU is non-exclusive and does not prevent either party from entering into similar agreements with other entities.
9. COUNTERPARTS This MoU is executed in two originals, each party retaining one. Both originals together shall constitute one and the same document.
