

**MEMORANDUM OF UNDERSTANDING
FOR ACADEMIC COLLABORATION
BETWEEN

DAKHA DEVI RASIWASIA COLLEGE CHABUA,

This Memorandum of Understanding is executed on this 11th day of April, 2022 at Dibrugarh University, Dibrugarh, Assam

BETWEEN

SRI SRI ANIRUDDHADEVA SPORTS UNIVERSITY, established by the Government of Assam by an act of the Assam Legislative Assembly (No. LGL. 164/2018/7) in the city of Chabua, Dibrugarh and presently operating from its temporary office on 2nd floor of DICC Building, Dibrugarh, Assam, India (hereinafter referred to as "SASU") which expression shall unless the context requires otherwise, mean and include its successors, representatives and permitted assigns of the SECOND PART.

DAKHA DEVI RASIWASIA COLLEGE, CHABUA, located in "Satra" township Chabua of Upper Assam, Established in 1971. This is a premier provincilized institution dedicated for higher learning especially for the students, from rural areas in an around Chabua. The college has been accredited by NAAC in the year 2016 and is presently offers UG regular courses in Arts, Commerce and Science streams and UG & PG programmes through distance mode under KKHSOU.

Article I RECITALS

1. SASU is the first and only sports university established by the Government of Assam by the Act of Assam Legislative Assembly (No. LGL. 164/2018/7) in the city of Chabua, Dibrugarh. The primary focus of the university is on quality education in the area of sports sciences, physical education, and its allied areas. The SASU is temporarily functioning from the DU campus since its inception.
2. DDR College offers various courses in Arts, Science, and Commerce streams and is interested to start sports activities for their students.
3. Since SASU and DDR College both are academic institutions, they are wishing to establish a relationship and cooperate.

Article II PURPOSE

1. Therefore, in the light of the mutually beneficial relations to be formed and of the mutual promises and covenants contained herein, which are agreed upon and ratified by the Parties, the parties agree on mutual exchange of the existing facilities as well as the facilities likely to be created in future by the respective institutions based on the convenience and availability of the resources for the agreed parties as stated below:
 - a. Playfields
 - b. Laboratory
 - c. Medical Facility

- d. Auditorium
- e. Conference hall
- f. Faculty
- g. Infrastructure
- h. Library
- i. Gymnasium

Article III TERMS OF COOPERATION

The terms of cooperation for each specific activity implemented under this MoU for cooperation shall be mutually discussed and agreed upon in writing by both the institutions before the initiation of that activity. Any such MoUs entered into, as outlined above, will form appendices to this MoU for cooperation.

The two institutions hereby agree on the following terms:

1. **Practice ground:** The DDR College will reserve or make available accommodation for SASU to use different playfields for different sports during the scheduled timing of the classes with prior discussion with its counterpart. The SASU will help DDR College in maintaining and developing existing practice grounds as far as possible subject to availability of fund.
2. **Library:** The SASU is going to have a library and online resources in terms of course contents, digital books, and journals focused in the area of physical education, sports, and its related fields. Faculty and students of DDR College will have access to these resources as per the guidelines issued by SASU. In turn, the faculty and students of SASU can avail the library resources of the DDR College as per guidelines framed by the DDR College administration.
3. **Laboratory:** All the Laboratories as and when established by SASU will be opened for the faculty and the students for use on need basis as per the allotted time slots if required.
4. **Medical facility:** Although SASU is arranging part-time Doctors, Physiotherapists during practice time of the students but during an emergency, the available medical facility of DDR College may extend their services to the students and staff of the SASU.
5. **Faculty:** Exchange of faculties will be subjected to the convenience and availabilities of the university and the college.
6. **Seminars / Conferences / Workshops / Short-term academic programs:** These programs may be jointly organized by the two institutions.
7. **Exchange of academic materials and other information:** Information on Research, Research Area, Publications, and Adopted Course Contents will be actively exchanged by the institutions.

8. **Joint research activities and publications:** Both the institutions will conduct joint research activities and publications.
9. **Ph.D. Guides:** Faculty of both the Institutions can become the Guide/Joint Guide for Ph.D. students of each other Institutions if the respective institution approves the name of the Faculty as Guide/ Joint Guide (whichever is applicable) of the candidate subject to the compliance of the relevant prescribed criteria in the regulation.
10. **Infrastructure Support:** The DDR College will provide infrastructure support to SASU in the form of classrooms, accommodation for classrooms, laboratories, common room, conference hall and auditorium, and playfields as per their requirement without hampering smooth functioning and conducting activities of the College. The DDR College will extend all possible support to SASU in their initial years in getting their academic programs approved by the NCTE and UGC.

Article IV ADMINISTRATIVE AND FINANCIAL ARRANGEMENTS

1. **Funds :** Both the institutions agree that all specific arrangements and plans for activities are to be negotiated and are dependent on the availability of funds and resources for any activity.
2. **Collaborative Research:** Both the institutions shall undertake collaborative research programmes through multi-disciplinary approach using the infrastructure and other research facilities available in both the institutions.
3. **Recurring Expenditures:** Payment of bills of actual electricity consumption used by SASU shall be borne by the Sports University.

Article V TERM

1. **Duration:** This Memorandum of Understanding will become effective on the final date of signing and will have duration of five years.
2. **Termination of the Memorandum of Understanding:** This Memorandum of Understanding may be terminated by either party by providing 30 days' written notice to the Coordinators listed below.
3. This MoU can only be amended in writing by mutual consent of the two institutions.
4. In case the MoU ceases to operate on account of termination thereof, the provisions which require continuance by virtue of this MoU, if applicable, to the extent necessary to secure the objectives of the provisions MoU as agreed upon, may be continued.

5. Any amendment or modification to the present text shall be submitted for review to the competent authorities, and shall not be binding unless reduced to writing and signed by both the institutions.
6. **Governing Law:** This MOU shall be governed and construed in accordance with the laws of India.
7. **Jurisdiction:** This MOU shall be subject to the exclusive jurisdiction of the courts of Dibrugarh, India.

Article VI
DESIGNATION OF COORDINATORS

1. Each party designates the following officials to serve as Coordinators under this Memorandum of Understanding. Individuals designated as Coordinators may be revised by either party by providing written notice to the current Coordinators.

General


