This Memorandum of Understanding is executed on this **26<sup>th</sup> day of May, 2022** in the Conference Hall of Dibrugarh University Guest House, Dibrugarh, Assam

**BETWEEN**

**DIBRUGARH UNIVERSITY**, established by an act of the Assam Assembly under the Dibrugarh University Act, 1965 having its office at Dibrugarh, Assam represented by its Registrar (hereinafter referred to as "DU" ) which expression shall, unless the context requires otherwise, mean and include its successors, representatives and permitted assigns of the FIRST PART.

**AND**

**SRI SRI ANIRUDDHADEVA SPORTS UNIVERSITY**, established by the Government of Assam by an act of the Assam Legislative Assembly (No. LGL. 164/2018/7) in the city of Chabua, Dibrugarh and presently operating from its temporary office on 2<sup>nd</sup> floor of DICC Building, Dibrugarh , Assam , India (hereinafter referred to as "SASU") which expression

shall unless the context requires otherwise, mean and include its successors, representatives and permitted assigns of the SECOND PART.

## Article I

### RECITALS

1. SASU is the first and only sports university established by the Government of Assam by the Act of Assam Legislative Assembly (No. LGL. 164/2018/7) in the city of Chabua, Dibrugarh. The primary focus of the university is on quality education in the area of sport sciences, physical education, and its allied areas. The SASU is temporarily functioning from DU campus since its inception.
2. DU introduced the Centre for Studies in Physical Education and Sports in the session 2009-2010 under the provision of the Dibrugarh University Act, 1965 aiming at imparting the knowledge of games and sports and physical well beings to produce competent professionals, expert and executors in implementation of current methods and techniques of physical education and sports to the society.
3. Since SASU and DU both are running academic courses in the same domain related to Physical Education & Sports, they are wishing to establish a relationship and cooperate.

## Article II

### PURPOSE

1. Therefore, in the light of the mutually beneficial relations to be formed and of the mutual promises and covenants contained herein, which are agreed upon and ratified by the Parties, the parties agree on mutual exchange of the existing facilities of the respective university as:
  1. Practice ground
  2. Library
  3. Laboratory
  4. Medical Facility
  5. Faculty
  6. Guest House
  7. Infrastructure

### Article III

#### TERMS OF COOPERATION

The terms of cooperation for each specific activity implemented under this MoU for cooperation shall be mutually discussed and agreed upon in writing by both Universities before the initiation of that activity. Any such MoUs entered into, as outlined above, will form appendices to this MoU for cooperation.

The two Universities hereby agree on the following terms:

1. **Practice ground :** The DU will reserve or make available for SASU to use different practice grounds for different sports during scheduled timing of the classes with prior discussion with its counterpart. The SASU will help in maintaining the practice grounds, if any additional maintenance is required. Similarly, the SASU shall make available its practice ground and other sports equipments of the students of DU
2. **Library :** The SASU is going to have a library and online resources in terms of course contents, digital books and journals focused in the area of physical education, sports and it's related fields. Faculty and students of Centre for Studies in Physical Education and Sports of DU will have an access to these resources. In turn, the faculty and students of SASU can also avail the library resources of the DU as per the library rules of the DU.
3. **Laboratory :** The SASU is going to establish sophisticated laboratory of Sport Psychology, Sports Biomechanics and Exercise Physiology, the facilities of which shall be available to the faculty and students of Centre for Studies in Physical Education and Sports of DU as per the allotted time slot, if required.
4. **Medical facility :** Although SASU is arranging part-time Doctors, Physiotherapist during practice time of the students but during an emergency, the medical centre of DU may extend their services to the students and staff of the SASU when the activities takes place at DU. Similarly the SASU shall arrange medical facilities for the students in the events taking place outside DU.
5. **Infrastructure support :** The DU will provide infrastructure support to SASU in the form of classrooms, accommodation for classrooms, conference halls and auditorium as per the their requirement without hampering smooth functioning and conducting activities of the DU and subject to availability in DU.
6. **Faculty :** Exchange of faculties will be subjected to the convenience and availabilities of the Universities.

7. **Seminars / Conferences / Workshops / Short-term academic programs :** These programmes may be jointly organized by the two Universities and mutual decision of arrangement of funds.
8. **Exchange of academic materials and other information:** Information on Research, Research Area, Publications, Adopted Course Contents will be actively exchanged by the Universities.
9. **Joint research activities and publications :** Both the Universities will conduct joint research activities and publications.
10. **Ph.D Guides :** Faculty of both the Universities can become the Co-Guide for Ph.D candidates of each other University if the respective University approves the name of the Faculty as a Co-Guide of the candidate subject to the compliance of the relevant prescribed criteria in the regulations of both the Universities.
11. Subject to availability, the Guest House facilities of DU can be used by SASU as per DU Guest House Management Rules. Similarly, SASU shall extend Guest House facilities as per their Rules as and when it is ready.

#### Article IV

##### ADMINISTRATIVE AND FINANCIAL ARRANGEMENTS

1. **Funds :** Both the Universities agree that all specific arrangements and plans for activities are to be negotiated and are dependent on the availability of funds and resources for any activity.
2. **Collaborative Research :** Both the Universities shall undertake collaborative research programmes through multi-disciplinary approach using the infrastructure and other research facilities available in both the Universities.

#### Article V

##### TERM

1. **Duration :** This Memorandum of Understanding will become effective on the final date of signing and will have duration of five years.
2. **Termination of the Memorandum of Understanding :** This Memorandum of Understanding may be terminated by either party by providing 30 days written notice to the Coordinators listed below.
3. This MoU can only be amended in writing by mutual consent of the two Universities.

4. In case the MoU ceases to operate on account of termination thereof, the provisions which require continuance by virtue of this MoU, if applicable, to the extent necessary to secure the objectives of the provisions of this MoU as agreed upon, may be continued.

5. Any amendment or modification to the present text shall be submitted for review to the competent authorities, and shall not be binding unless reduced to writing and signed by both the Universities.

6. **Governing Law.**

This MOU shall be governed and construed in accordance with the laws of India.

7. **Jurisdiction.**

This MOU shall be subject to the exclusive jurisdiction of the courts of Dibrugarh, India.

**Article VI**

**DESIGNATION OF COORDINATORS**

1. Each party designates the following officials to serve as Coordinators under this Memorandum of Understanding. Individuals designated as Coordinators may be revised by either party by providing written notice to the current Coordinators.


